

## **Data Processing Notice related to the HUPX Workshop and dinner to be held in 2023**

**HUPX Hungarian Power Exchange Company Limited by Shares** (registered office: 1134 Budapest, Dévai u. 26-28, company registration number: 01-10-045666, tax number: 13967808-2-41, contact: [info@hupx.hu](mailto:info@hupx.hu), hereinafter as: “**Data Controller**”) shall describe the data processing actions implemented in relation to the **HUPX Workshop and dinner** (hereinafter as: „**Event**”) to be held on 1st June 2023 at Kozmo Luxury Hotel (Budapest, Horváth Mihály tér 17, 1082, Hungary) in this Data Processing Notice (hereinafter as: “Data Processing Notice”).

This Data Processing Notice was prepared in line with Regulation (EU) 2016/679 of the European Parliament and of the Council on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (hereinafter as: **GDPR**), with due consideration of the provisions of Act CXII of 2011 on Informational Self-determination and Freedom of Information (hereinafter as: “**Information Act**”) as well, and the terms and expressions used herein shall be interpreted according to the definitions specified in Article 4 of the GDPR, and – in certain Sections – in Article 3 of the currently effective Information Act.

As data subject, you may at any time request more detailed information on the processing of your personal data or access your personal data, request their rectification, erasure or restriction of their processing, and may object to the processing of personal data and exercise your right to data portability. Please be informed that you have the right to withdraw your consent at any time. The withdrawal shall not affect the legal basis of the previous data processing.

In the event you disapprove of the processing of your personal data by the Data Controller or would like to receive more detailed information about processing of your personal data, you may contact the Data Controller directly by sending your request to [dataprotection@hupx.hu](mailto:dataprotection@hupx.hu). Should you have any complaints, you may contact directly the Hungarian National Authority for Data Protection and Freedom of Information (address: 1055 Budapest, Falk Miksa utca 9-11., mailing address: 1363 Budapest, Pf.: 9. E-mail: [ugyfelszolgalat@naih.hu](mailto:ugyfelszolgalat@naih.hu), website: [www.naih.hu](http://www.naih.hu)) or refer your case to court (regional court) in order to protect your data, and the court will address your case in an accelerated procedure.

**This Data Processing Notice provides information only and exclusively in terms of the aforementioned Event. For more detailed information about your rights as data subject, the way these rights can be exercised and the legal remedies, please read by all means the Data Processing Notice available on the Website of the Data Controller (<https://hupx.hu> menu item titled “Data Protection”)!**

In the case of registration, which is the basis of data management, the data subject's prior, informed, voluntary and definite (in the case of special data, in written format) consent is required. The Data Controller assures the data subject that he can withdraw his consent to data management at any time. In the case of recordings of the Event, the legal basis for data processing is the legitimate interest of the Data Controller, against which it is possible to object. After becoming aware of the withdrawal or protest, the Data Controller will no longer process

the data subject's personal data, he destroys or deletes them, if the data subject requests the limitation of data processing.

## 1. Registration for the Event

<b>Purpose of data processing</b>	Identification of natural persons participating in the Event, delivery of information related to participation and assessment of possible individual needs. In the case of successful registration, in order to prepare the same events of the Data Controller in the future, sending information electronically for 3 years after the event.
<b>Scope of processed data</b>	Participant's name, e-mail address, phone number, position, company, possible dietary preference (vegetarian, lactose-free, gluten-free).
<b>Scope of data subjects</b>	Persons invited and registered for the Event
<b>Legal basis of processing</b>	Informed, freely given and affirmative consent from the data subject as per Article 6(1)(a) and 9(2)a) of the GDPR.
<b>Time limit for data storage</b>	Until the data management purpose is achieved or until the consent of the data subject is withdrawn.
<b>Method of data processing</b>	Electronically.
<b>Source of the data</b>	Data collected from the data subject.
<b>Possible consequences of failure to provide the data</b>	The provision of personal data necessary for identification and contact (name, employer's name, position held and e-mail address) is required for the registration. Any failure to provide additional data will not affect the registration.
<b>Automated decision making and profiling</b>	The Data Controller does not perform any automated decision making or profiling.
<b>Who can access the personal data?</b>	The Data Controller's competent co-workers.
<b>Data transfer to third countries or to international organisations</b>	No data are transferred to third countries or to international organisations.

## 2. Recording, photo shooting the Event and publication of the recordings, photos

<b>Purpose of data processing</b>	Recording the Event and applying the photos and videos for communication purposes, moreover publishing on the offline and online external and internal interfaces of HUPX (mainly on social media channels and on the company's website ( <a href="http://www.hupx.hu">www.hupx.hu</a> )).
<b>Scope of processed data</b>	Photo, video and audio recordings of the persons concerned.
<b>Scope of data subjects</b>	Persons participating in the Event

<b>Legal basis of processing</b>	The legitimate interest of the Data Controller pursuant to Article 6(1)(f) of the GDPR, for which the Data Controller has carried out the interest assessment test.
<b>Time limit for data storage</b>	Until the data management purpose is achieved.
<b>Method of data processing</b>	Electronically.
<b>Source of the data</b>	Data collected from the data subject.
<b>Automated decisionmaking and profiling</b>	The Data Controller does not perform any automated decisionmaking or profiling.
<b>Who can access the personal data?</b>	The Data Controller's competent co-workers.
<b>Data transfer to third countries or to international organisations</b>	No data are transferred to third countries or to international organisations.
